After almost 1 ½ years, Planned Parenthood Peoria reopened its doors on May 20th. Although PP Peoria still sells chemical abortions the focus of their business appears to be their new cash cow: hormone treatments and monthly counseling for people confused about their true gender. Most likely the delay in opening was to line up with June "Pride" month.

As pregnant women will be encouraged to end the life of their unborn child(ren) at that location, KCRTL Prayer Warriors will begin to be present monthly on the sidewalks to offer prayers and education. #### The Abortion Pill at Galesburg's Walgreens and CVS

Beginning June 3rd, 2024 Knox County Right To Life Prayer Warriors will be standing on the sidewalk outside the Walgreens on Henderson in Galesburg from 11:30 am to 12:30 pm. We will be there the 1st Monday of the month during the summer months of June, July, and August, holding the signs "Pregnant, We Are Here To Help" and "Motherhood is Good", as we pray. If someone were to reach out to talk to us, we will hand out a referral to the Galesburg Women's Pregnancy Center just down the street.

Walgreens, CVS, and Rite-Aid filed paperwork in 2023 requesting permission from the FDA to sell the abortion pill through their in-store pharmacies. The FDA granted permission to Walgreens and CVS this March. Rite-Aid had already filed for bankruptcy in October 2023. The abortion pill currently results in the death of the majority of unborn babies, more than any other method of abortion.

#### Illinois Abortion Clinics See Increase In Out-Of-State Abortion Seekers

An increasing number of people are coming to Illinois in search of abortion care in the two years since the Supreme Court's Dobbs decision overturned the Roe v. Wade ruling.

Planned Parenthood of Illinois says 25% of its patients are from out of state — compared to about 4% pre-Dobbs. Clinics say they were prepared for the influx. "So we increased our clinic days from five days a week to six days a week. We do offer medication and in-clinic abortions on all of those days, as well as increased our staffing capacity by 40%," said Michele Landeau, chief operating officer of Hope Clinic in Granite City. #### **Out-Of-State Abortion Seekers Flock To Illinois**

Illinois had 37,300 abortion patients who traveled from other states to have the procedure in 2023, according to a new study and the New York Times. That's 41 percent of the 90,540 abortions performed in Illinois in 2023.

Abortion seekers in 2023 came from 15 states, including six Southern states, which ban the procedure. Overall, there were 1,010,700 abortions in all 50 states in 2023, according to the study. About 171,000 or 17 percent of the abortion seekers traveled to another state to have the procedure. Fourteen states ban abortions, including six Southern states. Abortions are legal in Illinois, which continues to draw residents from states that either ban abortions or have some restrictions on abortion. (Chicago Crusader)

### **Illinois Legislative News**

Here is a quick rundown of legislation in the just-ended 2024 session.

**House Bill 581** would enshrine into law that abortion is a viable treatment option for pregnant women experiencing emergencies in Illinois. The bill states doctors may provide abortions to patients experiencing life-threatening or altering conditions, including things like ectopic pregnancy, preeclampsia, and fertility loss related to pregnancy complications. The bill advanced out of the House primarily along party lines, 73-36. It cleared the Senate 40-19 on partisan lines on Sunday, May 26, and will need only a signature from the governor to become law.

House Bill 5239 bars authorities in Illinois from aiding another state's investigation of people coming to Illinois for reproductive health care, including abortions. It still allows authorities to cooperate in investigations of activities that would be violations of Illinois law and if cooperation is required under state or federal law. It also gives individuals the right to sue for civil damages if their information is improperly disclosed and gives minors the right to apply for public aid to obtain family planning services without the consent of their parents. #### **Abortion Via A Smart Phone?**

Planned Parenthood of the St. Louis Region expanded access to medication abortion in the State of Illinois. Residents in Illinois will now be able to access the abortion pill through a mobile app. Pregnant patients up to 10 weeks with an Illinois mailing address can have access through the Planned Parenthood Direct app. Once the app is downloaded, patients have to fill out a screening form and within 24 hours medication will be mailed.
